- 4. Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on "Submit" and also "Confirm" when prompted.
- 5. Upon confirmation, the message "Vote cast successfully" will be displayed.
- 6. You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
- 7. Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

## STATEMENT PURSUANT TO SECTION 102(2) OF THE COMPANIES ACT, 2013 ("the Act")

The Board of Directors of the Company, upon recommendation of the Nomination and Remuneration Committee, at its meeting held on 11 February 2022, appointed Mr. Rahul Mehta (DIN: 00165521) as an Additional and Independent Director of the Company to hold office for a term of 5 (five) consecutive years with effect from 11 February 2022, not liable to retire by rotation, subject to the approval of the Members of the Company, in terms of the provisions of Sections 149, 152 and other applicable provisions of the Companies Act, 2013 (the Act) and applicable regulations of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations).

As an Additional Director, Mr. Rahul Mehta holds office upto the date of the next Annual General Meeting of the Company and is eligible for being appointed as an Independent Director of the Company, subject to the approval of Members of the Company. The Company has received a notice in writing from a Member under Section 160 of the Act proposing the candidature of Mr. Rahul Mehta for the office of Director of the Company.

Mr. Rahul Mehta (aged 72 years) holds MBA from the Bajaj Institute in 1971. He has ability of stewardship and close liaison with the Government of India, including the ministry of textiles, the ministry of finance, and other government organisations and institutions. Mr. Mehta is acknowledged as one of the leaders of the Domestic Garment Industry. He has served as president of the Clothing Manufacturers Association of India (CMAI) for 7 terms. Under his leadership, CMAI not only attained greater heights and recognition, but also increased the services to its members.

Mr. Mehta represented India as a Board Member on the International Apparel Federation (IAF) based out of Netherlands and was the first Indian to serve as the President of Executive Committee of IAF. He is a member of the managing committee of Apparel Made-ups & Home Furnishing Sector Skill Council and a former member of the managing committee of the Apparel Export Promotion Council. He is Chairman of the Advisory Board of School of Fashion Technology, Pune.

Mr. Mehta launched the UFO Jeans, conceivably one of the earliest International Brands to come to India. He oversees most of the Domestic Business of the Creative Group, such as 109F, Fusion Beats, Urban Republic Jeans, Portico, etc.

He was first appointed as an Additional and Independent Director of the Company with effect from 11 February 2022. He had attended three Board meetings of the Company which were held since his appointment.

He is also Director on the board of other companies in India viz. Kamadgiri Fashion Limited, Gini & Jony Limited, Creative Casual India Private Limited, Creative Garments Private Limited, Creative Global Textile Mills Private Limited and Apparel Media Private Limited.

He holds membership/chairpersonship of Committees of the Company and other public companies as under:

He would be entitled to receive sitting fees for attending the meetings of the Board of Directors and Committees thereof. In addition, he would be entitled to receive commission as Non-Executive Director of the Company, as may be determined each year by the Board of Directors within the limits approved by the Members of the Company.

Mr. Mehta jointly with his relatives holds 16 equity shares in the Company and is not related to any other Directors and Key Managerial Personnel of the Company.

The Company has received a declaration from Mr. Rahul Mehta confirming that he meets the criteria of independence under the Act and Listing Regulations. Further, the Company has also received consent from Mr. Rahul Mehta to act as a Director in terms of Section 152 of the Act and a declaration that he is not disqualified from being appointed as a Director in terms of Section 164 of the Act. In the opinion of the Board, Mr. Rahul Mehta fulfils the conditions specified in the Act and rules made thereunder and Listing Regulations, for his appointment as an Independent Director of the Company and he is independent of the Management.

Considering his deep repository of knowledge and experience of over four decades in Manufacturing and operations in garments and consumer industry, Regulatory updates, Policy making, Market and technology know-how, the Board of Directors is of the opinion that it would be in the best interest of the Company to appoint him as an Independent Director for a period of five years with effect from 11 February 2022.



As per Regulation 17(1A) of the Listing Regulations, no listed company shall appoint or continue the directorship of a non-executive director who has attained the age of 75 years, unless a special resolution is passed to that effect and justification thereof to be indicated in the explanatory statement annexed to the notice for such appointment.

Please note that during the term of appointment of Mr. Rahul Mehta as an Independent Director, he would be attaining the age of 75 years. It is therefore, in order to comply with the provisions of the said Regulation, it is also proposed to seek approval of the Members of the Company by way of Special Resolution, for continuation of his directorship on the Board of Directors of the Company after he attains the age of 75 years.

Your Directors recommend Resolution as a Special Resolution for approval of the Members.

Save and except Mr. Rahul Mehta (being an appointee) and his relatives to the extent of their shareholding interest, if any in the Company, none of the Directors, Key Managerial Personnel of the Company and their relatives are concerned or interested, in any way, in the Resolution of this Notice.
